**NOTE:** Persons if appointed to the category of Clerk-cum-Typist should acquire Typing proficiency of 30 w.p.m. in English or 25 w.p.m. in Hindi within a period of four years from the date of appointment and till such time their appointments to this category will be provisional.

### 4. MINIMUM SPORTS NORMS FOR RECRUITMENT:

#### 4.1 Sportspersons desirous of applying for the posts in PB-1 ` .5200-20200 + Grade Pay ` .1900/2000 of the above against any of the Games as mentioned in the above table should have:

- (i) Represented the country in the International championships/events either in World Cup (Junior/Senior Category)/World Championships (Junior/Senior Category)/Asian Games (Senior Category)/Commonwealth Games (Senior Category).  
**OR**
- (ii) Obtained atleast 3<sup>rd</sup> position in Commonwealth Championships (Junior/Senior Category)/Asian Championships/Asia Cup (Junior/Senior Category)/South Asian Federations (SAF) Games (Senior Category)/USIC (World Railways) Championships (Senior Category).  
**OR**
- (iii) Obtained atleast 3<sup>rd</sup> position in Senior/Youth/Junior National Championships.  
**OR**
- (iv) Obtained atleast 3<sup>rd</sup> position in National Games organized under aegis of Indian Olympic Association.  
**OR**
- (v) Obtained atleast 3<sup>rd</sup> position in All India Inter University Championship organized under the aegis of Association of Indian Universities.  
**OR**
- (vi) Obtained 1<sup>st</sup> position in Federation Cup Championships (Senior Category).

#### 4.2 Sportspersons applying for the posts in PB-1 ` .5200-20200 + Grade Pay ` .1800 (erstwhile Gr.'D' posts) against any of the Games as mentioned in the above table should have:

- (i) Represented the country in Championship in either Commonwealth Championships (Junior/Senior Category)/Asian Championships/Asia Cup (Junior/Senior Category)/South Asian Federations (SAF) Games (Senior Category)/USIC (World Railways) Championships (Senior Category).  
**OR**
- (ii) Obtained atleast 3<sup>rd</sup> position in Federation Cup Championships (Senior Category).  
**OR**
- (iii) Represented a State of equivalent Unit, except in Marathon and Cross Country, in Senior/Youth/Junior National Championships.  
**OR**
- (iv) Obtained atleast 3<sup>rd</sup> position in Senior State Championships for all units and Districts of the state.

**Note:**

- (a) **In team sports**, only sportspersons who have actually played the sport in field, will only be eligible. Therefore, a sportspersons who represents as member of a team in any recognized sports events/championship but has actually not played in the field, will not be considered for recruitment against sports quota. Accordingly, the candidate has to produce a certificate for actual participation in field for his/her recognised sports achievements along with the application.
- (b) **In Athletics**, medal winning performance in National Inter State Senior Athletics Championships, will also be considered for recruitment against the posts having Grade Pay ₹.1900 in PB-1 ₹.5200-20200.
- (c) **In Chess**, following sports achievements will also be considered for recruitment in different Grade pay and Pay Bands listed below:

Only the current Annual All India Ranking will be considered for these purposes. Ranking in Mixed-Doubles shall not be considered.

- (e) **In Cricket at International level**, representation of Main Indian Seniors Team in a Test Match or in a Limited Overs One Day International Match or in a Twenty-20 Overs Match, are eligible for recruitment against the posts having Grade Pay ₹.1900/2000 in PB-1 ₹.5200-20200.
- (f) **In Cricket at National Level**, following sports achievements in 4Days/One Day Limited Overs/Twenty-20 Overs (Men) Championships (except Vizzy Trophy); organized under the aegis of BCCI, will also be considered for recruitment against the posts having Grade Pay ₹.1800 or 1900 in Pay Band ₹.5200-20200:

- (g) **In Golf**, for recruitment against the posts having Grade Pay ` .1800 in PB-1 ` .5200-20200; sportspersons having Indian Golf Union ranking up to 100, subject to single handicap i.e. less than 10 (in order of Merit/Amateur Merit list) will also be eligible for recruitment. Only the current Annual All India Ranking will be considered for these purposes.
- (h) **In Hockey**, for recruitment against the posts having Grade Pay ` . 1800/- in Pay band ` . 5200-20200, participation in International Tournaments of four or more nations will be considered. HOCKEY INDIA will be treated as recognised National Sports Federation for the game of Hockey for the purpose of recruitment.

All the championships mentioned above should have been conducted under the aegis of recognized International/National/State Sports Federation and also recognized by Railway Sports Promotion Board (RSPB).

#### **5. PERIOD OF RECKONING SPORTS ACHIEVEMENTS:**

For recruitment against sports quota, recognised sports achievements should be in the current and/or immediate previous two financial years and sports persons should be an active player. Therefore, the sports achievements on or after 01.04.2013 are only considered.

#### **6. AGE LIMIT (As on 01-01-2016).**

- a. **Those applying for Group 'C' in Pay Band-1 ` . 5200-20200 with Grade Pay ` . 1900/2000 & erstwhile Group 'D' posts in Pay Band-1 ` . 5200-20200 with Grade Pay ` . 1800/-:** The candidate must have attained the age of 18 years and must not have attained the age of 25 years as on **01.01.2016** i.e. must have been born **not earlier than 02<sup>nd</sup> January 1991 and not later than 01<sup>st</sup> January, 1998. No age relaxation is permissible.**

NOTE1: The candidates should note that, only the Date of Birth as recorded in the Matriculation/ Secondary Examination Certificate or an equivalent certificate as on the date of submission of applications will be accepted by the administration and no subsequent request for its change will be considered or granted.

NOTE2: The candidates should also note that, once a Date of Birth has been claimed by them and entered in the records of the Administration for the purpose of admission to the examination, no change will be allowed subsequently on any grounds whatsoever.

#### **7. EXAMINATION FEE/ EXEMPTIONS:**

- (i) The examination fee for all candidates except those : ` .100/- (inclusive of mentioned in para (ii) below postal expenses)
- (ii) For candidates belonging to SC/ST/Ex- Servicemen/Persons with Disabilities (PWDs), Women, Minorities and Economically Backward Classes : **NIL**

NOTE 3: Minorities will mean Muslims, Christians, Sikhs, Buddhists and Zorastrians(Parsis).

NOTE 4: Economically Backward Classes will mean the candidates whose family income is less than ` .50, 000 per annum. The following authorities are authorized to issue income certificate for the purpose of identifying economically backward classes:

- (i) District Magistrate or any other revenue officer up to the level of Tahasildar.
- (ii) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
- (iii) BPL card or any other certificate issued by the central government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
- (iv) Union Minister may also recommend to Chairman/RRBs/RRCs for any persons from anywhere in the country.
- (v) Sitting members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.
- (vi) The income certificate issued by the authorities mentioned above would have to be in the format prescribed at **Annexure-II** which is available on South Western Railway Website. This would have to be issued on the letter head of the issuing authority.

- 7.2 Remittance of examination fee in any other form except Indian Postal Order will not be accepted.
- (a) IPOs issued before the date of issue of Employment notice or after the closing date will not be accepted and the application will be rejected.
  - (b) The particulars of Indian Postal Order submitted as examination fee should also be indicated at the prescribed place in the application form.
  - (c) Candidates must write their name, full address in the space provided in the Indian Postal Order.
  - (d) The examination fee is not refundable/transferable/adjustable under any circumstances.

## 8. HOW TO APPLY:

- 8.1 Candidates should carefully read all the instructions given in the employment notification before filling the application form.
- 8.2 Application as per the prescribed format shall be submitted on A-4 size good quality paper. The Application can also be downloaded from the website of Railway Recruitment Cell, Hubli ([www.rrchubli.in](http://www.rrchubli.in)). **The application should be filled in English/Hindi language only. The applications written in other than in English/Hindi languages will be rejected.**
- 8.3 The application should be filled by the candidate in his/her own handwriting and signed.
- 8.4 The candidate has to affix/paste (not to be pinned) one recent passport size color photograph without cap & without coloured glasses (not older than three months), duly attested by signing partially on the application and partially on the photo in the space provided for the purpose. Candidate is also required to enclose one extra passport size photograph (same as the one affixed/pasted on the application) along with the application.

- 9.6 For candidates residing in Assam, Meghalaya, Manipur, Arunachal Pradesh, Mizoram, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahaul & Spriti districts and Pangti sub-division of Chamba district of Himachal Pradesh, Andaman, Nicobar and Lakshadweep islands and the candidates residing abroad, the closing date for receipt of applications by post will be 15.02.2016.

**10. RECRUITMENT PROCESS:**

The recruitment will be based on trials, assessment of sports achievements and general intelligence/personality etc. The candidates **who are found fit** in trials only will be considered for next stage.

**11. MEDICAL EXAMINATION:**

The Candidates recommended for appointment will have to pass the requisite medical fitness test(s) conducted by the Railway Administration to ensure that the candidates are Medically FIT to carry out the duties connected with the post. Only those candidates who are Medically FIT would be empanelled for appointment.

**12. GENERAL CONDITIONS:**

- 12.1 Before applying to the post, the candidate should ensure that he/she fulfils all the eligibility conditions.
- 12.2 The name and initial of the candidate and father's name appearing in school/college certificates and in sports certificates should be one and the same. There should be no difference.
- 12.3 The specific position (100/200 Mtrs run/ 400 Mtrs Run/ 800 mtrs Run/3000 M Steeple Chase/10000 M Run/110 Mtrs Hurdles/ 400 Mtrs Hurdles/ Heptathlon/20 Kms

Walk/Triple Jump/ High Jump/Pole Vault/Hammer/Discuss/Shot Put/ 1000 mtrs Time Trial/ 4000 Mtrs Indl Pursuit Track/ Attacker/Blocker/Play Maker/ Pivot/ Forward/ 55 Kg/ 75 Kg/93 Kg/50, 100 & 2000 mtrs Breast Stroke/400, 800 & 1500 mtrs Free Style/Individual Medley/Medium Pacer/Left Arm Spinner/ 69 Kg/ 77 Kg/ Doubles/Forward/Back etc.) played in the particular game/event if applicable should be mentioned in the application without fail.

- 12.4 The candidates serving in any Government Department or Public Sector Undertaking including Railways should apply through proper channel or should apply directly with **NO OBJECTION CERTIFICATE** from the employer to avoid delay. Advance copy of the application from such candidates without '**No Objection Certificate**' from the employer will not be entertained. Please note that no application received after the prescribed date will be entertained.
- 12.5 The decision of the Railway Administration in all matters relating to eligibility, acceptance or rejection of the application, penalty for false information and mode of selection shall be final and binding on the candidates.
- 12.6 The applicant is liable to be appointed against any suitable post in **Pay Band ` 5200-20200 with Grade Pay ` 1900/2000 or Grade Pay ` 1800/-** as the case may be, anywhere on South Western Railway.
- 12.7 Candidates will have to undergo prescribed training course as applicable for the post as per existing instructions.
- 12.8 Canvassing in any form shall disqualify the candidature.
- 12.9 The candidates should be in readiness to appear for the trials at short notice after the last date for submission of application is over. Please check the website of RRC, Hubli at **www.rrchubli.in** for getting the information regarding eligibility list, trials, etc.
- 12.10 The candidates are required to obtain caste certificates in the prescribed proforma from the appropriate authority and produce the original certificate at the time of verification. The candidature of the candidates submitting Caste Certificates issued by the authorities other than those authorised, are liable to be disqualified.
